

About this Guide

Huntington's Disease (HD) is a hereditary brain disorder which leads to multiple physical and mental disabilities that increase over time. In people with the gene that causes HD, symptoms typically begin to appear between the ages of 35 and 45, but the disease may strike those as young as two or as old as 80. Juvenile onset Huntington's Disease (JHD) affects fewer than 10% of all individuals with HD.

JHD often presents different symptoms and challenges than adult onset HD. Ordinary issues of childhood and adolescence are intertwined with the progressive multiple disabilities caused by the disease.

There are programs at the Federal, State and community level which can help families meet the needs of their child or children with JHD. However, finding these programs and getting access to services can be challenging to even the most patient caregiver. Helping families facing JHD locate programs in their region is the goal of this guide.

The Juvenile Onset Huntington's Disease Resource Guide is the result of extensive research and collaboration with social workers, medical professionals and HD families across the country. Our goal is to present as complete a listing of useful resources as possible.

Supplemental Security Income

Supplemental Security Income (SSI) is a federal program of cash assistance to disabled needy individuals of any age, including children. Under SSI, children are considered disabled if they have a physical or mental condition which is so severe that it results in marked and severe functional limitation. The individual's condition must last or be expected to last at least twelve (12) months, or be expected to result in the child's death.

Everyone eligible for Social Security Disability Insurance (SSDI) benefits is also eligible for Medicare after a 24-month qualifying period. The first 24 months of disability benefit entitlement is the waiting period for Medicare coverage. Some states provide an additional cash benefit to individuals receiving SSI.

The exact amount of SSI for which a claimant is entitled depends on what the individual (or the parents in the case of a child) owns and how much income he or she has. Eligibility requirements and benefit payments for federal SSI benefits are identical throughout the 50 states and the District of Columbia. A disability law attorney can also provide state-specific information and guidance in planning for eligibility for SSI benefits.

The HDSA Chapter Social Workers and the Center of Excellence Social Workers are very knowledgeable about the resources in their state and region. Social workers will help you get started with services, and then help with advocacy as needed.

How does the Social Security Administration define "disabled"?

An individual under age 18 is "disabled" if he or she has a medically determinable physical or mental impairment, which:

- · results in marked and severe functional limitations; and
- can be expected to result in death; or
- has lasted or can be expected to last for a continuous period of not less than 12 months.

If the individual is age 18 or older, the disability must also result in the inability to do any substantial gainful activity before benefits are granted.

What to expect when you apply

When you file an application for SSI benefits based on disability, the agency must first decide whether your family meets the income and resource criteria and other eligibility requirements.

They will ask for:

- Information about your child's physical or mental impairment(s);
- names, addresses, and telephone numbers of doctors, hospitals and any other medical sources he/she has seen;
- Dates of treatment and the kinds of treatment the child has received from doctors, hospitals and other medical sources;
- · Names of each prescription and non-prescription medicine that he/she takes and the doctor who prescribed it;
- The kinds of medical tests that have been performed, when and where they were done, and the name of the prescribing physician;
- The name, address, and telephone number of the child's school and teacher.

They will contact doctors, hospitals, schools, teachers, therapists, relatives or others who can provide useful information about your child's impairment(s) and functioning.

If they cannot get enough information from your doctors and other people to decide if your child is disabled, they may arrange and pay for an examination or testing by a qualified medical professional (who may be your own physician, psychologist, optometrist, or speech/language pathologist or other healthcare provider).

Statements from the child's medical team

In the application for SSI benefits, you will include statements from the child's medical team for the DDS examiners. If possible, have the child examined by an HD specialist, who may be able to make a stronger case based on their expertise. You can find an HD specialist in your area by contacting an HDSA Center of Excellence or your local HDSA Chapter.

The medical team's written statement should include the fact that the child has symptomatic JHD, not just a genetic condition. The statements should be as specific as possible, including the child's diagnosis, a description of the child's disabilities and their prognosis. This is especially important because JHD is a rare disorder and the physicians and examiners at Disability Determination Services (DDS) may not understand its impact on the child.

As you go through the application and appeals process, remain courteous to the people you deal with at Social Security and at the DDS office. They will probably do more for you if you have a friendly relationship. Keep copies of all the child's medical records. Respond promptly to letters and notices and go to any medical exams scheduled by DDS. Do not let important deadlines lapse. If you have questions, calling your local DDS office may be easier and more effective than trying to get through to the Social Security office.

Medicaid

Medicaid is a jointly funded and administered state and federal welfare program that pays the qualifying medical expenses for those individuals whose financial resources fall below the program's established minimums. Medicaid may pay for such services as hospital and doctor bills not covered by insurance, home healthcare services, medical transportation, and nursing home care.

Medicaid is administered by each state, unlike Medicare, and both are partially funded by the U.S. Centers for Medicare & Medicaid Services (CMS). No two states' Medicaid programs are alike, yet there are certain federally mandated standards common to all Medicaid programs across the nation.

In most states, once a child gets SSI benefits, they can also enroll in Medicaid to help pay medical bills. Many states also have waiver programs under which an individual who is disabled but does not meet the financial criteria may still become eligible for benefits. Eligibility for Medicaid, including home and community-based services waivers, is not determined by the Federal government.

TEFRA

Home Care for Children

In some states, children under age 18 who need institutional-level care and live at home may keep Medicaid eligibility while getting home care, if that care is less costly to the government than institutional care. This program is called TEFRA and is also known as the Katie Beckett option. To qualify for TEFRA benefits, the child must be disabled according to the Supplemental Security Income (SSI) definition of disability and must meet the medical-necessity requirement for institutional care. Because there are so few nursing home beds available for children under the age of 16, TEFRA may be an important option for late stage care.

TEFRA is different than Medicaid in that parental income and resources are not considered in awarding benefits. Only the income and resources of the child are counted. Parents may be required to pay a parental fee calculated by using the parents adjusted gross income (before taxes) from last year's tax return and comparing it with the Federal Poverty Guideline.

Children who receive SSI but lose coverage intermittently due to fluctuating parental income may be eligible for TEFRA benefits in the months they do not receive SSI. The child's parent or guardian can apply for TEFRA at the Medicaid office in the child's county of residence.

State Programs for Children with Special Healthcare Needs

Most states have programs for Children with Special Healthcare Needs. Many of these programs are listed in the Resources by State section of this guide. Among these programs is the Katie Beckett Waiver, also known as the Deeming Waiver of the 2176 Model Waiver. The waiver is part of the Medicaid program and it pays for home-based medical services for children with chronic disabilities whose parents make too much to meet the income requirements of Medicaid. The program is administered by individual states and provisions vary. Ask your primary care physician or medical social worker about additional programs in your state.

A note on web addresses
